I, J. W. Buffa, am Senior Geologist employed by Pegasus Gold Corporation, 255 West Moana Lane, Suite 108, Reno, Nevada 89509. I assisted in and supervised the sampling of the Imperial #1-25 unpatented lode mining claims in Sections 5 and 6, Township 23 North, Range 50 East, and Sections 5 and 6, Township 23 1/2 North, Range 50 East, M.D.B.&M. during the period May 13, 1987, through August 25, 1987. Curt P. Dechert, Michael J. Pasecznyk and Michael G. Maslowski, geologists employed by Pegasus, Reno, Nevada, also assisted in this project. Over 135 samples were taken and assayed by Rocky Mountain Geochemical of Nevada, 840 Greg Street, Reno, Nevada, totalling over 540 individual analyses.
