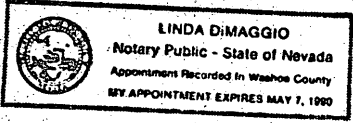

Gregory McN. French (M.S. Degree, Geology, South Dakota School of Mines), an employee of Atlas Precious Metals Inc., made geologic maps and collected approximately 100 rock chip samples on Glen claims 1-37. The rock chip samples were analyzed for Au, As, Sb and Hg.

The mapping and sampling succeeded in defining geologic and geochemical anomalies that will be followed up with future work.
