THIS IS TO CERTIFY that the BS No. 248 lode mining claim was located by:

on the 17<sup>th</sup> day of June, 1987, situated in the Unknown Mining District, Eureka County, State of Nevada.

Said claim is located in the following 1/4 section(s):

- SW 1/4 of Section 28, Township 26 N., Range 49 E., M.D.B. & M.
- SE 1/4 of Section 29, Township 26 N., Range 49 E., M.D.B. & M.
- NE 1/4 of Section 32, Township 26 N., Range 49 E., M.D.B. & M.
- NW 1/4 of Section 33, Township 26 N., Range 49 E., M.D.B. & M.

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 8, Township 25 N., Range 49 E., Mount Diablo Base and Meridian, thence North, 16,781 feet and East, 2,985 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,490 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,480 feet from the location monument in an Easterly direction and 10 feet in a Westerly direction, together with 295 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

- thence, East, 745 feet to the North Side Center (Cor. No. 2),
- thence, East, 745 feet to the Northeast Corner (Cor. No. 3),
- thence, South, 590 feet to the Southeast Corner (Cor. No. 4),
- thence, West, 745 feet to the South Side Center (Cor. No. 5),
- thence, West, 745 feet to the Southwest Corner (Cor. No. 6),
- thence, North, 590 feet to the Northwest Corner (Cor. No. 1), the point and place of beginning.

The monumentation and marking of the corners was completed by the 10th day of August, 1987.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
