CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the STOCK No. 6 lode mining claim was located by:

Said locator claims under and by virtue of the mining laws of the United States of America and the State of Nevada, 1,500 feet along the vein thereof, together with 300 feet on each side of the center of said vein. The general course of said vein being Southeasterly and Northwesterly with 1,490 feet claimed in a Southeasterly direction and 10 feet in a Northwesterly direction from the Discovery Monument, at which the Notice of Location is posted.

Said lode claim is situated in the Cortez Mining District, County of Eureka, State of Nevada and is located in all or in part of the following 1/4 Section(s):

- NW 1/4 of Section 32, Township 27 N., Range 48 E., M.D.B. & M.
- NE 1/4 of Section 32, Township 27 N., Range 48 E., M.D.B. & M.
