THIS IS TO CERTIFY that the STOCK No. 22 lode mining claim was located by:

The general course of said vein being Southeasterly and Northwesterly with 1,490 feet claimed in a Southeasterly direction and 10 feet in a Northwesterly direction from the Discovery Monument, at which the Notice of Location is posted.
