THIS IS TO CERTIFY that the STOCK No. 34 lode mining claim was located by:

The general course of said vein being Northwesterly and Southeasterly with 1,490 feet claimed in a Northwesterly direction and 10 feet in a Southeasterly direction from the Discovery Monument, at which the Notice of Location is posted.
