CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the STOCK No. 44 lode mining claim was located by: Cortez Gold Mines
Cortez, Nevada 89821

on the 6th day of August, 1987. Said locator claims under and by virtue of the mining laws of the United States of America and the State of Nevada, 1,500 feet along the vein thereof, together with 300 feet on each side of the center of said vein. The general course of said vein being Southeasterly and Northwesterly with 1,490 feet claimed in a Southeasterly direction and 10 feet in a Northwesterly direction from the Discovery Monument, at which the Notice of Location is posted.

Said lode claim is situated in the Cortez Mining District, County of Eureka, State of Nevada and is located in all or in part of the following 1/4 Section(s):

- SE 1/4 of Section 20, Township 27 N., Range 48 E., M.D.B. & M.
- NE 1/4 of Section 29, Township 27 N., Range 48 E., M.D.B. & M.
- 1/4 of Section _____, Township 27 N., Range 48 E., M.D.B. & M.
- 1/4 of Section _____, Township 27 N., Range 48 E., M.D.B. & M.

To tie this claim to the Public Survey, begin at the Southeast Corner of Section 31, Township 27 N., Range 48 E., Mount Diablo Base and Meridian, thence North, approximately 11,148 feet and East, approximately 2,748 feet to the Northwest corner (Cor. No. 1) of this claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch diameter x 5 foot long post monuments firmly set in the ground with an aluminum tag marked with the appropriate monument designation. The description of such claim is:
