thence North, approximately 11,530 feet and West, approximately
10,030 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,490 linear feet along the course of the mineral-bearing
ledge, lode or vein, extending 1,480 feet from the location monument in a
Northerly direction and 10 feet in a Southerly direction, together with
295 feet on each side of the center of the ledge for the entire length of the
claim.

The exterior boundaries of this claim are clearly marked by substantial
3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing
applicable monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

thence, East, 590 feet to the Northeast Corner (Cor. No. 2),

thence, South, 745 feet to the East Side Center (Cor. No. 3),

thence, North, 745 feet to the West Side Center (Cor. No. 6),

thence, North, 745 feet to the Northwest Corner (Cor. No. 1),
the point and place of beginning.
