

CERTIFICATION OF LOCATION OF LOSE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned individual hereby certifies that he has located the
X No. 75 lode mining claim in Section 12,
Township 21 North, Range 48 East, Mount Diablo Base and Meridian,
in the UNKNOWN Mining District, County of Eureka,
State of Nevada on the 3 day of August, 1987.

The claim is 1500 feet in length and 600 feet in width, and
50 feet is claimed in a West Southwest direction and 1,450
feet in a East Northeast direction from the location monument upon
which the Notice of Location is posted, together with 300 feet on each
side of the center of the claim. The general course of the lode deposit
and premises is from the West Southwest to the East Northeast.

The position of each corner of this claim is shown on the mining
claim map recorded herewith. The number, position and markings on each
corner and side center monument is as follows:

As erected on the ground, each corner and side line center monument
consists of a durable plastic (PVC) pipe at least 3 inches in diameter
by 4 feet in length set 1 foot in the ground, and is marked as described
above with a plastic label affixed to the monument post. The
monumentations and marking of the above described corners and side
line centers on the ground was completed within 60 days from the date
of posting and the notice of location; and the location work consisted
of making and recording of duplicate claim maps and payment of the fees
prescribed by NRS 517.040.

The claim is located in the following unsurveyed section(s), portions
of which are projected in the following legal subdivision(s):

NE 1/4 of Section 13, Township 21 North, Range 48 East, Mt. Diablo B&M
SE 1/4 of Section 12, Township 21 North, Range 48 East, Mt. Diablo B&M
