CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the NORTH 17 Lode Mining Claim on this 14th day of July, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW (SW) (Quarter) Section(s) 21 (16), Township 25 North, Range 50 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:
