CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the NORTH 18 Lode Mining Claim on this 14th day of July, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a N 65°W direction and 1490 feet in a S65°E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N65°W and S65°E.
