CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the NORTH 19 Lode Mining Claim on this 14th day of July, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW (SW)(SE) (Quarter) Section(s) 21 (16)(16), Township 25 North, Range 50 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, <u>600</u> feet in a <u>S25°W</u> direction to Post No. 2, marked - <u>NORTH 19</u> - <u>2</u>
Thence, <u>750</u> feet in a <u>N65°W</u> direction to Post No. 3, marked - <u>NORTH 19</u> - <u>3</u>
Thence, <u>750</u> feet in a <u>N65°W</u> direction to Post No. 4, marked - <u>NORTH 19</u> - <u>4</u>
Thence, <u>600</u> feet in a <u>N25°E</u> direction to Post No. 5, marked - <u>NORTH 19</u> - <u>5</u>
Thence, <u>750</u> feet in a <u>S65°E</u> direction to Post No. 6, marked - <u>NORTH 19</u> - <u>6</u>
Thence, <u>750</u> feet in a <u>S65°E</u> direction to Post No. 1, marked - <u>NORTH 19</u> - <u>1</u>

the point of beginning and all posts being 3"X4" durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a N 65°W direction and 10 feet in a S65°E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N65°W and S65°E.

To tie this Claim to the Public Survey, begin at the SE corner, Section 33, Township 25 N., Range 50 E., Mt. Diablo P.M., and bear N65°W, 9169 feet and N25°E, 13459 feet to the northeast corner of this Claim.
