CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the NORTH 42 Lode Mining Claim on this 14th day of July, 1987, situated in the Mining District, Eureka County, Nevada.
