CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the NORTH 48 Lode Mining Claim on this 14th day of July, 1987, situated in the Unknown Mining District, Eureka County, Nevada.
