Ruby Hill Mining Company caused to be made and performed on or for the benefit of said claims, the annual labor and improvements required by the laws of the United States and the State of Nevada, which work was done between December 20, 1986 and August 31, 1987 for the assessment year ending at 12:00 o'clock Meridian, September 1, 1987.

There was expended for said labor and improvements, an amount in excess of Thirty-Five Thousand Dollars (\$35,000+), and they were made at the expense of Ruby Hill Mining Company. The annual labor and improvements for said claims consisted of:

A series of nine agitation cyanidation leach tests and five column leach tests were performed on representative ore collected from various points on the property. Said tests were conducted by Bateman Metallurgical Laboratories under agreements with Ruby Hill Mining Company.


A column leach test was performed by Challenge Mining Company on representative ore collected from the Ruby Hill property.



Surface cuts were made in mine waste dumps, drill sites were prepared and roads were repaired using a tractor with dozer. Said work was conducted by Eureka Custom Contractors under agreements with Ruby Hill Mining Company.

Samples were collected from surface cuts and rock outcrops. Assay determinations were made by Skyline Labs, Inc., and Rocky Mountain Geochemical of Nevada.


The work was conducted on various claims including the Wac Fraction, Oriental and Belmont Consol. M. S. 196, Cyanide M. S. 4686, Bowman M.S. 175, Jumbo, Jumbo No. 3, Adams and Farren and Deep Mine M.S. 116, Surplus M.S. 85, Skylark M.S. 56, Fries M.S. 308, Main Shaft M.S. 2864, Buckeye M.S. 37, Savage M.S. 42, and Champion M.S. 38.

The above named and described unpatented lode mining claims and adjoining patented lode mining claims comprise a contiguous group of lode mining claims owned in common by Ruby Hill Mining Company. The said labor was performed and improvements made for the benefit of each and all of said mining claims comprising said contiguous group, as a part of a general plan of development and they tend to improve and develop each and all of said mining claims. The amount expended for the value of said labor and improvements is not less than One Hundred Dollars (\$100.00) for each of the mining claims comprising said contiguous group.
