That the Certificate of Location of each and all of the above referenced claims have been filed for record in the offices of the County Recorder of Eureka County, in the town of Eureka, and the Nevada BLM in the City of Reno, and such certificates are hereby referred to, and by such reference made a part hereof for all particulars therein shown.

That said labor was performed intermittently during the period between September 1, 1986 and September 1, 1987. That such work to advance the development of said claims consisted of making a compilation, analysis and summary report of geology indicated in the drilling performed on the claims. In addition, restoration of access roads and drill sites was performed in accordance with Bureau of Land Management requirements.

That the results of the work are as follows: The compilation and analysis of the geology resulting from previous drilling indicated the feasibility of additional drilling.



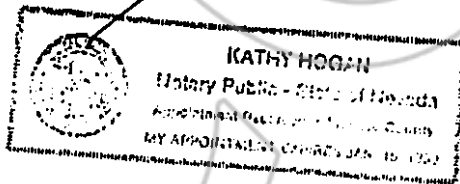
That the foregoing is set forth as the detailed report required by 30 USC, Sec. 28-1.


