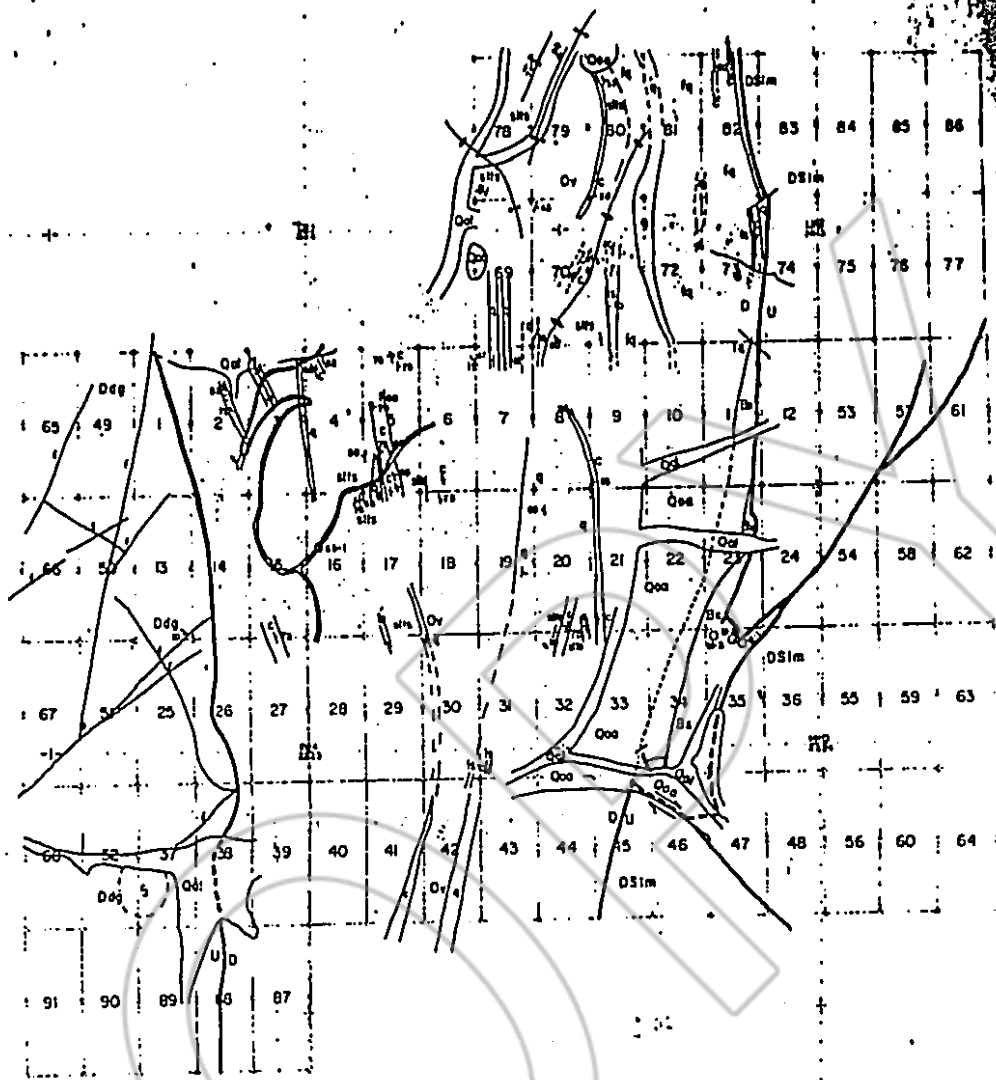

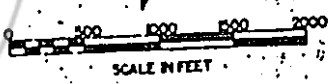

SUMMARY REPORT

October 19, 1987

This detailed report and accompanying geologic map is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the STAG #1 - #91 (STAG #33-#36 and STAG #48 as amended) group of 91 lode mining claims situated in the Mineral Hill Mining District of Eureka County in the State of Nevada. The claim notices are recorded in the records of the Eureka County Recorder in Eureka, Nevada and in the BLM mining records in Reno, Nevada. The BLM serial numbers for the subject claims are NMC 163380, NMC 244521-NMC 244524, NMC 163385-NMC163421, NMC 167191-NMC 167195, and NMC 163422-NMC 163465. This report and the accompanying geologic map are the result of a portion of the assessment work for the assessment year ended September 1, 1987 on the aforementioned mining claims.

The work consisted of both reconnaissance and detailed geologic mapping of a portion of the southern and most of the western claims in the claim block to further evaluate the discover of valuable mineral deposits located thereon and to assist in further planning for exploration and development work. The work was performed between August 1 and September 1, 1987 by William D. Collins of 20802 Pleasant Park Road, Conifer, Colorado 80433, the locator/owner of the claims and a geologist of 32 years experience with a B.Sc. degree in Geological Engineering obtained from the University of Idaho in 1955. The cost and/or value of the geologic mapping and associated work exceeded \$9100.00 and was borne by William D. Collins, the locato/owner of the STAG claim group.

The results of the geologic mapping are shown on the accompanying geologic map entitled "Partial Geologic Map, STAG Lode Claim Group" updated on Sept. 27, 1987. In as far as the mapping extended, it showed structural and rock type features which correlated with known mineral occurrences and geochemical anomalies. When completed, the geologic mapping and further exploration work will be coordinated to guide exploration and development drilling to further evaluate the claim group.
