The claim is 1,500 feet long and 600 feet wide, such that 750 feet are claimed in a Northerly direction and 750 feet are claimed in a Southerly direction from the discovery monument at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the North direction to the South direction.

The definition of the boundaries of the claim, together with the erection of boundary or corner monuments and the marking of such monuments, was completed by September 3, 1987.

The location work consisted of making a claim map as provided in N.R.S. 517.040.


