

CERTIFICATE OF LOCATION - LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

Aquarian Mining Exploration, Inc., a Nevada corporation and D. P. Ward, an individual, by and through their lawful and authorized agent, Bruce Broadhead, gives notice that they claim the land described below as a lode mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing their rights, state and certify as follows:

1. The name of the claim is BOB 27.
