

CERTIFICATE OF LOCATION - LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

Aquarian Mining Exploration, Inc., a Nevada corporation and D. P. Ward, an individual, by and through their lawful and authorized agent, Bruce Broadhead, gives notice that they claim the land described below as a lode mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing their rights, state and certify as follows:

1. The name of the claim is BOB 51.

The general course of the lode or vein is east-west as nearly as may be determined.

7. Corner No. 1 (the NW corner) of this claim bears 800 feet west and 2400 feet south from the NW corner of Section 35 T32N, R49E, M.D.B.&M.
