CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XVII 1/2 Lode Mining Claim on this 7<sup>th</sup> day of August, 1987, situated in the MT Hope Mining District, EUREKA County, Nevada.

Said Claim is located in the SU, NW, SE, NE (Quarter) Section(s) 32 Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 750 feet in a Southerly direction to Post No. 2,
- Thence, 750 feet in a Southerly direction to Post No. 3,
- Thence, 600 feet in a Westerly direction to Post No. 4,
- Thence, 750 feet in a Northerly direction to Post No. 5,
