CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH #3 Lode Mining Claim on this 7th day of AUGUST, 1987, situated in the 11th ME Mining District, ELIKA County, Nevada.
