CERTIFICATE OF LOCATION - NEVADA 112914

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XVIIH 26 Lode Mining Claim on this 7th day of August, 1987, situated in the MT HOPE Mining District, CLARK County, Nevada.
