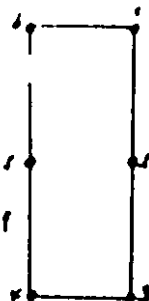

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH #14 Lode Mining Claim on this 7th day of AUGUST, 1987, situated in the MT HOPE Mining District, EUREKA County, Nevada.

Said Claim is located in the SW 1/4 (Quarter) Section(s) 23, Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a SOUTHERLY direction to Post No. 2,
Thence, 750 feet in a SOUTHERLY direction to Post No. 3,
Thence, 600 feet in a WESTERLY direction to Post No. 4,
Thence, 750 feet in a NORTHERLY direction to Post No. 5,
Thence, 750 feet in a NORTHERLY direction to Post No. 6,
Thence, 600 feet in a EASTERLY direction to Post No. 1,

the point of beginning and all posts being 4" x 4" x ¹/₈".

The claim monument on which the Notice is posted lies approximately midway between the two sides and is 10 feet from the SOUTH end and 1,490 feet from the NORTH end.

To tie this Claim to the Public Survey, begin at the SOUTHWEST corner, Section 30, Township 23 NORTH, Range 52 EAST, Mt. Diablo P.M., Bear NORTH, 3,000 feet, and WEST, 2,000 feet to the northeast corner of this Claim.
