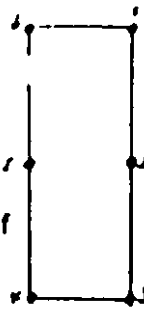

CERTIFICATE OF LOCATION - NEVADA 112923

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the X 114 #15 Lode Mining Claim on this 7th day of August, 1987, situated in the MT. HOPE Mining District, EUREKA County, Nevada.

Said Claim is located in the S10 (Quarter) Section(s) 23, Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 750 feet in a SOUTHWESTLY direction to Post No. 2,
- Thence, 750 feet in a SOUTHWESTLY direction to Post No. 3,
- Thence, 600 feet in a WESTERLY direction to Post No. 4,
- Thence, 750 feet in a NORTHWESTLY direction to Post No. 5,
- Thence, 750 feet in a NORTHWESTLY direction to Post No. 6,
- Thence, 600 feet in a EASTERLY direction to Post No. 1,

the point of beginning and all posts being 4" x 4" x $\frac{4}{5}$ '.

The claim monument on which the Notice is posted lies approximately midway between the two sides and is 10 feet from the NORTH end and 1,450 feet from the SOUTH end.

To tie this Claim to the Public Survey, begin at the SOUTHWEST corner, Section 30, Township 23 NORTH, Range 52 EAST, Mt. Diablo P.M., bear NORTH, 1,500 feet, and WEST, 8,400 feet to the northeast corner of this Claim.
