# CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XNH #16 Lode Mining Claim on this 7<sup>th</sup> day of AUGUST, 1987, situated in the MT. DIABLO Mining District, ELISA County, Nevada.

Said Claim is located in the SW & NW (Quarter) Section(s) 23, Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a SOUTHERLY direction to Post No. 2,  
Thence, 750 feet in a SOUTHERLY direction to Post No. 3,
