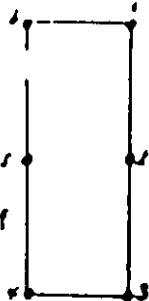

CERTIFICATE OF LOCATION - NEVADA 112925

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the X 1114 #17 Lode Mining Claim on this 14 day of August, 1987, situated in the Mt. Hope Mining District, EUREKA County, Nevada.

Said Claim is located in the SW 1 SE (Quarter) Section(s) 23 Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a SOUTHERLY direction to Post No. 2,
Thence, 750 feet in a SOUTHERLY direction to Post No. 3,
Thence, 600 feet in a WESTERLY direction to Post No. 4,
Thence, 750 feet in a NORTHERLY direction to Post No. 5,
Thence, 750 feet in a NORTHERLY direction to Post No. 6,
Thence, 600 feet in a EASTERLY direction to Post No. 1,

the point of beginning and all posts being 4" x 4" x ⁴/₈".

The claim monument on which the Notice is posted lies approximately midway between the two sides and is 10 feet from the NORTH end and 1490 feet from the SOUTH end.

To tie this Claim to the Public Survey, begin at the SWTHWEST corner, Section 30, Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., bear NORTH, 1500 feet, and WEST, 7800 feet to the northeast corner of this Claim.
