CERTIFICATE OF LOCATION - NEVADA 112950

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH # 6.4 Lode Mining Claim on this 6th day of August, 1987, situated in the MT HOPE Mining District, BIREKA County, Nevada.

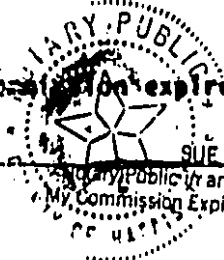
