THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH #68 Lode Mining Claim on this 6th day of AUGUST, 1987, situated in the MT HOPE Mining District, EUREKA County, Nevada.
