CERTIFICATE OF LOCATION - NEVADA 112960

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH # 74 Lode Mining Claim on this 6th day of AUGUST, 1987, situated in the Mt. Hope Mining District, EUREKA County, Nevada.

Said Claim is located in the SE & SW (Quarter) Section(s) 3 Township 22 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a SOUTHWESTLY direction to Post No. 2,

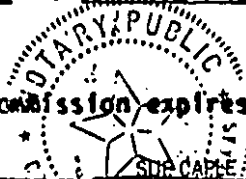
