CERTIFICATE OF LOCATION - NEVADA 112962

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH # 76 Lode Mining Claim on this 6<sup>th</sup> day of August, 1987, situated in the MT. HOPE Mining District, ELIABA County, Nevada.
