CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH #80 Lode Mining Claim on this 6th day of AUGUST, 1987, situated in the MT. HOPE Mining District, EURKA County, Nevada.
