CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XATH #86 Lode Mining Claim on: this 6th day of AUGUST, 1987, situated in the Mt. Hope Mining District, EUKEKA County, Nevada.
