CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the KMH #87 Lode Mining Claim on this 6<sup>th</sup> day of AUGUST, 1987, situated in the Mt. Hope Mining District, EUREKA County, Nevada.

Said Claim is located in the SE (Quarter) Section(s) 27 Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 300 feet in a SOUTHERLY direction to Post No. 2,
- Thence, 750 feet in a WESTERLY direction to Post No. 3,
- Thence, 750 feet in a WESTERLY direction to Post No. 4,
- Thence, 300 feet in a NORTHERLY direction to Post No. 5,

the point of beginning and all posts being 4" x 4" x <sup>4</sup>/<sub>5</sub>".
