CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH # 88 Lode Mining Claim on this 6th day of August, 1987, situated in the Mt Hope Mining District, EUREKA County, Nevada.

Said Claim is located in the SW (Quarter) Section(s) 26, Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a Southerly direction to Post No. 2,

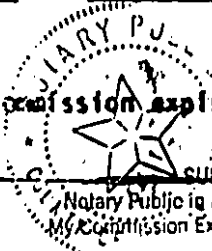
