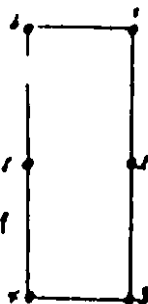

CERTIFICATE OF LOCATION - NEVADA 112975

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH # 87 Lode Mining Claim on this 6th day of AUGUST, 1987, situated in the MT HOPE Mining District, BUREAU County, Nevada.

Said Claim is located in the SE (Quarter) Section(s) 26 Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a SOUTHERLY direction to Post No. 2,
- Thence, 750 feet in a WESTERLY direction to Post No. 3,
- Thence, 750 feet in a WESTERLY direction to Post No. 4,
- Thence, 600 feet in a NORTHERLY direction to Post No. 5,
- Thence, 750 feet in a EASTERLY direction to Post No. 6,
- Thence, 750 feet in a EASTERLY direction to Post No. 1,

the point of beginning and all posts being 4" x 4" x 1/2".

The claim monument on which the Notice is posted lies approximately midway between the two sides and is 10 feet from the EAST end and 1450 feet from the WEST end.

To tie this Claim to the Public Survey, begin at the SOUTHWEST corner, Section 30, Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., bear SOUTH, 4200 feet, and WEST, 10500 feet to the northeast corner of this Claim.

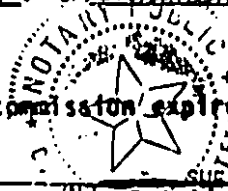
