CERTIFICATE OF LOCATION - NEVADA 112980.

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH No 4 Lode Mining Claim on this 6th day of August, 1987, situated in the MT HOPE Mining District, QUICKA County, Nevada.
