CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XVIIH #95 Lode Mining Claim on this 6<sup>th</sup> day of August, 1987, situated in the Mt. Hope Mining District, GARDNER County, Nevada.

Said Claim is located in the NE; NW (Quarter) Section(s) 34, 35, Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a Southerly direction to Post No. 2,
- Thence, 750 feet in a Westerly direction to Post No. 3,
- Thence, 750 feet in a Westerly direction to Post No. 4,
- Thence, 600 feet in a Northerly direction to Post No. 5,

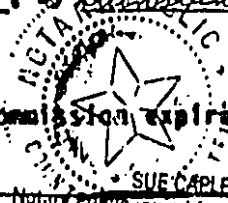
