CERTIFICATE OF LOCATION - NEVADA 112983

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the M.H.M. #97 Lode Mining Claim on this 6<sup>th</sup> day of August, 1987, situated in the Mt. Hope Mining District, Esmeralda County, Nevada.

Said Claim is located in the NE, NW (Quarter) Section(s) 34, 35, Township 23 North, Range 51 East, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,
