THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH # 98 Lode Mining Claim on this 6<sup>th</sup> day of August, 1987, situated in the MT. HOPE Mining District, ELIOLA County, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 35, Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:
