CERTIFICATE OF LOCATION - NEVADA 112986

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the X MH 100 Lode Mining Claim on this 6<sup>th</sup> day of AUGUST, 1987, situated in the MT HOPE Mining District, EUREKA County, Nevada.

Said Claim is located in the NEW (Quarter) Section(s) 35 Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a SOUTHWESTLY direction to Post No. 2,
