CERTIFICATE OF LOCATION - NEVADA 113001

THE UNDERSIGNED, hereby certifies that Mount Hope Mines, Inc., by its Agent, the undersigned, does hereby locate the XMH #171 Lode Mining Claim on this 7<sup>th</sup> day of August, 1987, situated in the MT. HOPE Mining District, ELIOT County, Nevada.

Said Claim is located in the SW 1/4 SE (Quarter) Section(s) 35 Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a SOUTHWEST direction to Post No. 2,
- Thence, 750 feet in a WEST direction to Post No. 3,
- Thence, 750 feet in a WEST direction to Post No. 4,
- Thence, 600 feet in a NORTHWEST direction to Post No. 5,
- Thence, 250 feet in a EAST direction to Post No. 6,

the point of beginning and all posts being 4" x 4" x 4/8.

The claim monument on which the Notice is posted lies approximately midway between the two sides and is 10 feet from the EAST end and 1,490 feet from the WEST end.
