IN WITNESS WHEREOF, the said Grantors have hereunto set their hands the day and year first above in this Deed written.

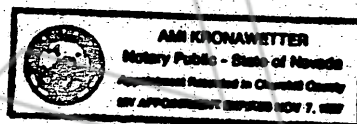
