CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Atlas Precious Metals, Inc. by its Agent, the undersigned, does hereby locate the MURPHY 106 Lode Mining Claim on this 1st day of September, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW(NE)SW(SE)Quarter Section(s) 23(23)(23)(23) Township 24 N., Range 50 E., Mt. Diablo P.M., and is more particularly described as follows, to wit:

the point of beginning and all posts being 3" X 4' durable plastic posts

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a easterly direction and 1490 feet in a westerly direction, together with 180 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is easterly and westerly.
