

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Atlas Precious Metals, Inc. by its Agent, the undersigned, does hereby locate the MURPHY 115 Lode Mining Claim on this 1st day of September, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SW(SE)(NW)(NE) (Quarter) Section(s) 23(23)(26)(26) Township 24 N., Range 50 E., Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 600 feet in a southerly direction to Post No. 2, marked - MURPHY 115-#2  
Thence, 750 feet in a westerly direction to Post No. 3, marked - MURPHY 115-#3  
Thence, 750 feet in a westerly direction to Post No. 4, marked - MURPHY 115-#4  
Thence, 600 feet in a northerly direction to Post No. 5, marked - MURPHY 115-#5  
Thence, 750 feet in a easterly direction to Post No. 6, marked - MURPHY 115-#6  
Thence, 750 feet in a easterly direction to Post No. 1, marked - MURPHY 115-#1

the point of beginning and all posts being 3" X 4" durable plastic posts.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a easterly direction and 10 feet in a westerly direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is easterly and westerly.

To tie this Claim to the Public Survey, begin at the Northwest corner, Section 22, Township 24 N., Range 50 E., Mt. Diablo P.M., and bear south 5060 feet and east 8578 feet to the northeast corner of this Claim.


