**CERTIFICATE OF LOCATION - NEVADA**

THE UNDERSIGNED, hereby certifies that Atlas Precious Metals, Inc. by its Agent, the undersigned, does hereby locate the MURPHY 117 Lode Mining Claim on this 1st day of September, 1987, situated in the Unknown Mining District, Eureka County, Nevada.
