CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Atlas Precious Metals, Inc. by its Agent, the undersigned, does hereby locate the MURPHY 118 Lode Mining Claim on this 1st day of September, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 26 Township 24 N., Range 50 E., Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a southerly direction to Post No. 2, marked - MURPHY 118 -#2
- Thence, 750 feet in a westerly direction to Post No. 3, marked - MURPHY 118 -#3
- Thence, 750 feet in a westerly direction to Post No. 4, marked - MURPHY 118 -#4
- Thence, 600 feet in a northerly direction to Post No. 5, marked - MURPHY 118 -#5
- Thence, 750 feet in a easterly direction to Post No. 6, marked - MURPHY 118 -#6
- Thence, 750 feet in a easterly direction to Post No. 1, marked - MURPHY 118 -#1

the point of beginning and all posts being 3" X 4' durable plastic posts.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a easterly direction and 1490 feet in a westerly direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is easterly and westerly.
