CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Atlas Precious Metals, Inc. by its Agent, the undersigned, does hereby locate the MURPHY 120 Lode Mining Claim on this 1st day of September, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 26, Township 24 N., Range 50 E., Mt. Diablo P.M., and is more particularly described as follows, to wit:

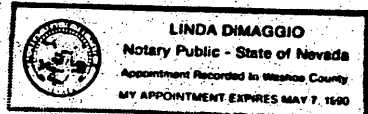
