CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the WI 112A Lode Mining Claim on this 8th day of October, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SW (Quarter) Section(s) 3 Township 22 North, Range 50 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

- Beginning at the northeast corner post No. 1,
- Thence, 600 feet in a south direction to Post No. 2, marked - WI 112A - 2
 - Thence, 600 feet in a south direction to Post No. 3, marked - WI 112A - 3
 - Thence, 60 feet in a west direction to Post No. 4, marked - WI 112A - 4
 - Thence, 600 feet in a north direction to Post No. 5, marked - WI 112A - 5
 - Thence, 600 feet in a north direction to Post No. 6, marked - WI 112A - 6
 - Thence, 60 feet in a east direction to Post No. 1, marked - WI 112A - 1

the point of beginning and all posts being 3" X 4" durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 610 feet in a north direction and 590 feet in a south direction, together with 30 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is north and south.

To tie this Claim to the Public Survey, begin at the NE corner, Section 23, Township 22 N., Range 50 E., Mt. Diablo P.M., and bear north, 12613 feet and west, 8590 feet to the northeast corner of this Claim.
