- Thence, 750 feet in a S65°E direction to Post No. 6, marked - NORTH 207 - 6

The number of linear feet claimed in length along the course of the vein from the  
point of discovery is 1490 feet in a N 65°W direction and 10 feet in a  
S65°E direction, together with 300 feet on each side of the center of the  
vein or lode for the entire length of the claim.
